This is a special meeting [webinar] of the PEHSC Medical Advisory Committee to continue its review of the proposed changes to the 2021 statewide EMS treatment protocols. Dr. Doug Kupas, Commonwealth EMS Medical Director, led today's meeting.

There were 3 documents disseminated to the committee in advance of today's meeting:

1. Draft BLS Protocols (ver. 12/06/20)
2. Draft ALS Protocols (ver. 12/06/20)
3. Draft CCT Protocols (ver. 11/11/20)

Dr. Kupas asked if there are any questions regarding the BLS protocols, which were reviewed at the November 11th MAC meeting and updated. There were no questions or comments at this time.
